CEO Report

We've been busy and there's so much to tell you about!

It's been a month since our last Aspectives newsletter and I have a very good excuse...I've been working hard on your behalf! My apologies in advance for a very long CEO report.

FutureSkills Lab

While attending the CANNEXUS Conference in Ottawa last month, I had the opportunity to meet with Rachel Wernick, Associate Assistant Deputy Minister, Skills and Employment Branch, Employment and Social Development Canada, and 6 of her senior staff. I introduced (and re-introduced for some) them to ASPECT, the work we are doing with our partners across Canada, the challenges with federally administered government grants, and how we can utilize our existing infrastructure of community-based organizations to support Canada's employment needs.

Much was discussed in the hour-long meeting with three topics were at the forefront: ASPECT's existing and developing relationships with indigenous-serving organizations, the business sector, and the provincial government, funding opportunities to develop postemployment supports, and a request for our feedback on a <u>discussion paper</u> about the formation of the FutureSkills Lab. This week and next, I'll be meeting with Canadian Coalition of Community-Based Employability Trainers (CCCBET) board members to discuss a coordinated pan-Canadian response.

RFP Workshops

ASPECT presented 2 workshops in Vancouver on February 1 & 2. Both sessions were sold out and the feedback on both was

stellar. Thanks to Liz Busch, Director, Outreach and User Experience at Ministry of Citizens Services, for presenting the content in an interesting and informative way.

Some people were not able to attend those dates, so we are looking at putting together a third session in Vancouver. If you are interested, please let me know.

We also had encouraging feedback for presenting a Project Management Course to help manage the request for proposal (RFP) process. It will likely be pulled together over the next month or so.

The Federation's Social Policy Forum


Last week I attended the Fed's (Federation of Community Social Services of BC)
